Dear [elected official],

As a constituent and volunteer for the American Cancer Society Cancer Action Network (ACS CAN), I am writing to urge you help save lives from tobacco-related illnesses and end Big Tobacco's long legacy of predatory marketing to youth and communities of color.

Personalize your message

Please urge the Administration and the FDA to implement a comprehensive and swift prohibition on menthol in cigarettes and all flavors in cigars. Decades of tobacco industry documents show how the tobacco industry has deliberately targeted Black individuals with menthol cigarettes and flavored cigars, as well as LGBTQ+ and limited-income families. Menthol flavoring makes it easier to start smoking and harder to quit.

One year ago, the FDA released a proposed rule that would prohibit menthol in cigarettes and flavors in cigars. This regulation would target the production and sale of these products, not individual users.

Ending menthol flavoring in cigarettes and all flavors in cigars is a long overdue step forward in reducing youth tobacco initiation, helping adults quit and reducing tobacco-related cancer. It will also combat Big Tobacco's unfair targeting of Black communities, who consistently report the highest prevalence of menthol cigarette use. This rule needs to be finalized and put into place.

I urge you to advocate for finalizing this rule, including signing on to any legislation or letters that support its finalization.
