We did have a price increase starting in 2023 so the gurney price is different. The onsite cylinder replacements price is the same. Do you want me to provide just one quote with both the cylinder replacements and gurneys or two separate quotes?

In the meantime, will the cylinder replacements take place within the hyperbaric suite or elsewhere? Hi Renee:

Please find attached the two quotes. They are both still addressed to Adam's attention. I hope that is okay.

We had a price increase effective this month so the gurneys and cabling on the cylinder replacement quote are higher. The ground kit cabling was a significant increase so I extended a discount:-). The cylinder replacement and Ground Continuity Test Kit prices did not change. Freight did not change.

Also, I want to point out that the removal of the old gurneys is the hospital's responsibility. This was not clear on the last quote. If you want us to dispose of the old gurneys, it is no problem. The cost is \$1,200.00. Let me know if you would like for us to do this and I will update the quote.

Adam sent me a photo of the room. The space is sufficient! Yay.


Your cylinders will reach their maximum service lifespan in March. Our normal lead time is up to twelve weeks from order which puts this out into end of April or beginning of May assuming

we get the PO by end or January/beginning of February. Our production team is looking to see if there is any way of improving on the lead time. I was hoping to have an answer today but they are still working to see if it is possible. Three weeks ago, we would have been able to have cylinders by end of March but now other orders have filled the slots. I will advise as soon as I know.

Lastly, speaking of the PO, when should we expect the PO? Th sooner we get the PO, the sooner we can lock in production of the cylinders.

Good morning, Renee. Please email it to me. Thank you! The PO will get reviewed. If all looks okay, then a PO Confirmation will be sent.

Please make sure that our payment terms are stated somewhere on the PO. Hospital POs usually have default payment terms of Net 30 Days that can't be changed on the PO. Therefore, our payment terms can be stated as a Note or Comment. Also, please make sure that the address of where the cylinders and gurneys should be shipped is accurate. The cylinder crates are on casters. They cannot be hand carried so the crates need to be able to be pushed from the drop off point to the final destination, i.e., the HBO2 suite.

Once the PO is received and finalized, I will set up a call with you and your team to review the logistics and schedule. Thank you again.

Dear Renee:

It was so nice to talk with you this morning! Per our call, please find attached two updated quotes. A few comments on the quotes are below:

- 1. The quotes are dated January 3, 2023 prior to when our new pricing went into effect. Quote expires after 30 days on February 3, 2023.
- 2. As long as we receive the PO no later than February 3, 2023, the old pricing will be honored.
- 3. The Delivery on the Cylinder Replacement quote states "Standard lead time is 10-12 weeks ARO. However, if PO is received no later than Feb 3rd, 2023,

delivery will be on March 24th, 2023. If PO is received after February 3rd, 2023, order is subject to new pricing and standard lead time."

Please review the quotes and let me know if you have any changes.

Also, as discussed, production gave me the great news this morning that they will be able to have two cylinder kits ready to ship on March 17^{th} . Transit time is one week so we would be able to deliver the cylinder replacements and perform the service the weekend of March 24^{th} - 26^{th} . One of your chambers' cylinder expires on March 5, 2023, the other on March 20^{th} . You will only have four days without a chamber! Assuming that all falls into place, please confirm that the weekend of March $24^{th} - 26^{th}$ works for your team to do the cylinder replacements. We will be scheduling four technicians so I want to reserve the weekend and technicians so no one else does.
